As the director, I was in charge of students, academics, administrators and the external partner (OUA). I was on the panel to recruit casual staff and advised on the recruitment of full time staff. I looked after the innovation, compliance, quality assurance and accreditation of the program. This program grew exponentially under my leadership as we took advantage of the government regulations surrounding the new academic qualification requirements of financial advisors.

Embracing new technology and efficiency approaches in online programs. In 2003, I undertook my first leadership role as the director of a program offered through OUA (Open Universities Australia). My KPI (verbal conversation) at the time was to do nothing as the school was planning to phase out this unsuccessful program. Within six months in my position, it was apparent that this was not a profitable program and that there were ways to improve it. We adopted an efficiency approach that meant we stopped sending students printed notes and used CDs and online download. The savings were in terms of printing costs and the administrator's time. The administrator who was working with me appeared to lack confidence and we worked together to overcome this. She has now been promoted to a higher position and is performing relatively well. In a conference, I demonstrated that 'fancy and expensive' slides made minimal contributions to knowledge as there are other areas of online teaching where investments would be more effective. OUA rewarded me for this contribution with a 'winning formula award'.

• Supervision of research projects

I lead research groups that enable students and colleagues to publish in Tier A and Tier A star. Academics were able to save their jobs whilst others were promoted for their research performance. In addition, we managed to secure research income. Another outcome was the teaching research nexus that improved the quality of the finance program.

• Coaching of junior academic staffs

I have worked in the academic arena since 1999 and since that time I have gained significant knowledge as to how to navigate through multi-disciplinary schools. When I analyse my publications I identify a number of my co-authors were also my junior colleagues. I find collaborating with colleagues to be more enjoyable and rewarding than working on my own and this shows my leadership stage of "Reactive & Socialized Mindset". At present I have several other projects that I am collaborating on with other junior colleagues (both funded and unfunded). One example worth mentioning is in 2014, I travelled to the RMIT campus in Vietnam where I worked with junior colleagues in an effort to jump start the research culture within the finance discipline and this has led to a number of junior staff publishing. In a similar manner, I have mentored and supported several junior/senior faculties at RMIT in Melbourne and UniSA. The fact that I celebrate Thursdays, Fridays, birthdays, Christmas, EID, weddings, funerals and other social activities with my colleagues shows that I have a good relationship with them.
